



**SUPPLEMENTAL/BID BULLETIN
ADDENDUM NO. 1**

REF: Security Services for STBR PDOs, Bataan PDO and VISMIN PDOs for Three (3) Years

Upon the evaluation of the Technical Working Group (TWG) and the BAC in its BAC Resolution No. 84, Series of 2009, this Addendum is issued to clarify and/or amend some provisions in the bid documents. This shall form an integral part of the Bid Documents, to wit:

A. CLARIFICATIONS

Eligibility Check Requirements (First Envelope) –

1. Bidder may submit one (1) ECR regardless of the number of lot/s they are participating in.
2. If in case the Bidder filed the ITR manually, the Bidder shall submit the following:
 - 2.1. Statement from the authorized representative explaining the reason/s for non-filing of the requested ITR thru the EFPS; and
 - 2.2. Memorandum/Certification or any supporting document issued by the issuing agency certifying that the system is not available during the time of filing.
3. Under 16 (f), the Bidder shall submit certification/s from NLRC that the Bidder/Security Agency has no pending case filed with NLRC at the place where the principal office is situated and at the place/s where the Bidder has its branch/es, and at the place/s where the Bidder will be bidding. The number of certificate/s to be submitted must correspond to the number of branch/es a Bidder is participating.
4. The Cash Deposit Certificate/Credit Line Certificate equivalent to ten percent (10%) shall be based on the Approved Budget for the Contract (ABC) per lot for one (1) year.
5. The period covered for clearances or certificate of good payment standing with SSS, PhilHealth and Pag-Ibig under 16(k) is the latest – 2009 or if not yet available, then 2007-2008.
6. As an attachment to Form No. 2, Service contract is also acceptable.

Technical Requirements (Second Envelope) –

1. Supplier/Bidder shall submit one (1) Technical Requirements for each lot including the required Bid Security.
2. The computation of Bid Security shall be based on the Approved Budget for the Contract (ABC) for one (1) year.
3. For Bataan PDO, the required number of guards should be **four (4) who shall provide 24-hour security services to said PDO** (1 guard:2am to 10am; 2 guards:10am to 6pm; 1 guard:6pm to 2am).

Financial Requirements (Third Envelope) –

1. Supplier/Bidder shall submit one (1) Financial Requirements for each lot.
