The Philippine Charity Sweepstakes Office (PCSO), through the Bids and Awards Committee intends to apply the sum of **Two Hundred Fifty Two Million Pesos (PhP252,000,000.00)** being the Approved Budget for the Contract (ABC) for the supply and delivery of **Sub-Lot A:12,600 Single Packs of Dental Supplies and Sub-Lot B:12,600 Single Packs of 11 Pre-Selected Common Medicines**. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The PCSO now invites eligible Bidders for the Re-Bidding of **Sub-Lot A:12,600 Single Packs of Dental Supplies and Sub-Lot B:12,600 Single Packs of 11 Pre-Selected Common Medicines in lots as above indicated**. The effectivity of the contract will be fifteen (15) calendar days upon receipt of the Purchase Order (PO). The description of an eligible Bidder is contained in Section II of the Bidding Documents, ITB.

Re-Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and **is restricted to Filipino citizens, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A.138)**. Only Bids from Bidders who pass the eligibility check will be opened. The process for the eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to eligibility, technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.

Interested Bidders may obtain further information from PCSO at the address given below from 8:00am to 5:00pm.

A complete set of Bidding Documents for Lots 1 to 17 may be secured for free from July 30 to August 5, 2009 by interested Bidders from the address below. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.

The PCSO will hold a Pre-Bidding Conference for Lots 1 to 17, open to all interested parties on **August 6, 2009, 10:00am** at the Executive Lounge, 4/F Main Building, E. Rodriguez Sr. Avenue, Quezon City. The **deadline for submission of Bids for Lots 1 to 17** is at **8:30am of August 17, 2009** to the Bids and Awards Committee, c/o **The Office of the General Manager** located at the 3rd Floor of the Main Building. **Bids will be opened on August 17, 2009 at 9:00am** in the presence of the Bidders' representatives who choose to attend at the PCSO Executive Lounge, 4th Flr.. **Late Bids shall not be accepted.**

The PCSO reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
