



SUPPLEMENTAL/BID BULLETIN
ADDENDUM NO. 1
REF: ONE (1) UNIT 45-SEATER SHUTTLE BUS

Upon the recommendation of the Technical Working Group, and the evaluation of the BAC in its BAC Resolution No. 35, Series of 2009, this Addendum is issued to clarify and/or amend some provisions in the bid documents. This shall form an integral part of the Bid Documents, to wit:

A. Eligibility Check Requirements (First Envelope)

1. For Eligibility Check Requirement No. 2 – Certified true copy of 2009 Mayor's permit/municipal license, the BAC hereby amends the requirement, to read as:

1.1 "Certified true copy of 2009 Mayor's permit/municipal license or its equivalent document."

2. For Eligibility Check Requirement No. 10 – The Income Tax Returns (ITRs) for the years 2006 and 2007 **duly filed thru the EFPS**, the BAC hereby clarifies the requirement, to wit:

If in case the Bidder filed the ITR manually, the Bidder shall submit the following:

2.1. Statement from the authorized representative explaining the reason/s for non-filing of the requested ITR thru the EFPS; and

2.2. Memorandum/Certification or any supporting document issued by the issuing agency certifying that the system is not available during the time of filing.

3. For Eligibility Check Requirement No. 8 – Statement of on-going and similar completed government and private contracts for the years 2005, 2006 & 2007, including contracts awarded but not yet started (**minimum of five (5) largest contracts, pls. attach POs/NOA's/Sales Invoices**) (*form supplied, Form No. 2*). **The largest Single Contract should have a value of at least 50% of the ABC of the project to be bid**, the BAC hereby clarifies the requirement, to wit:

3.1. The Bidder shall submit a list of five (5) contracts within the 3-year period not necessarily submitting a contract for each year, so long as it meets the 50% requirement.

4. For Eligibility Check Requirement No. 16 (a) – Company Profile including (a) list of clients/customers for the Year 2006, 2007 & 2008, both public and private, (b) list of products/product line, the BAC hereby clarifies the requirement, to wit:

4.1. As a general rule, Bidder should be in existence for the last three (3) years prior to publication. However, if the Bidder is short of the 3-year requirement, it may include its international status. To establish its international status, Bidder should submit documents duly authenticated by the proper authority.

B. Technical Requirements (Second Envelope)

1. As required under Checklist of Technical Requirements No. 7, prospective Bidders shall attach evidence of the product being offered in the form of brochures or samples or pictures of the samples, or any other form mentioned in the said checklist.

2. Technical Specifications - the BAC hereby clarifies the requirement, to wit:



| Jump seats | Jump seats/foldable center seats is mandatory. The Bidder shall provide jump seats/foldable center seats in all rows exclusive of the 45-seat requirement. |
| Upholstery, Seat belts | The upholstery should be leatherette which is the minimum requirement. As to seatbelts, the minimum requirement should be four (4) in the front row and one (1) for the driver. |
| Emergency Exit (Breakable Glass) Location | The location should be in the middle. |
| First Aid Kit Box (mounted) | For so long as it is mounted, the location is immaterial. |
| DVD/VCD Sony Brand | Sony Brand which is of high quality and tested already per previous purchases and usage in the said buses. Further, a comparable brand in said equipment/accessories will still be acceptable. |
| CBU units allowed? | As long as the minimum requirements per technical specifications are met, then it doesn't matter whether or not it is a Complete Body Unit. |

3. 3 years warranty or 100,000kms, whichever comes first - the BAC hereby amends the requirement, to wit:

3.1. "Provision of 3 years warranty or 100,000kms, whichever comes first, in lieu of the 10% Retention Money."

ALL OTHER MATTERS NOT INCLUDED IN THIS ADDENDUM ARE HEREBY MAINTAINED BY THIS COMMITTEE.
