



INVITATION TO BID FOR THE HIRING OF THIRTY (30) SECURITY GUARDS FOR ONE (1) YEAR TO BE ASSIGNED AT PCSO OFFICES LOCATED AT PICC, PASAY CITY AND QUEZON CITY

The Philippine Charity Sweepstakes Office (PCSO) through the Bids and Awards Committee (BAC) intends to apply the sum of **Seven Million Seven Hundred Sixty-Five Thousand Five Hundred Sixty Pesos (P7,765,560.00)** for one (1) year, being the Approved Budget for the Contract (ABC) for the project. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The PCSO now invites bids for the Bidding of **Thirty (30) Security Guards for one (1) year to be assigned at PCSO Offices located at PICC, Pasay City and Quezon City**. The Delivery of Services shall be for a period of one (1) year from receipt of the Notice to Proceed. Bidders should have completed, **within three (3) years** from the date of submission and receipt of bids, contract similar to the Project. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested Bidders may obtain further information from the PCSO and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.

A complete set of Bidding Documents may be purchased by interested Bidders on **June 24, 2011 up to 8:30am of July 13, 2011** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P1,000.00**.

Bid documents may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PCSO, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents simultaneously with or not later than the submission of their bids.

The PCSO will hold a Pre-Bid Conference on **July 1, 2011 at 10:00am**, at the PCSO Conference Room, Ground Floor, PICC Media Center, Secretariat Building, PICC CCP Complex, Roxas Boulevard, Pasay City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before 9:00 am of **July 13, 2011**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The PCSO reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
