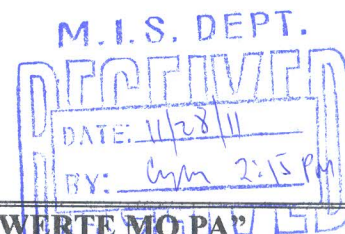

2. For Item No. 34 – short or long grain are acceptable; 200 pieces per ream; and
3. For Item No. 37 - short or long grain are acceptable.
