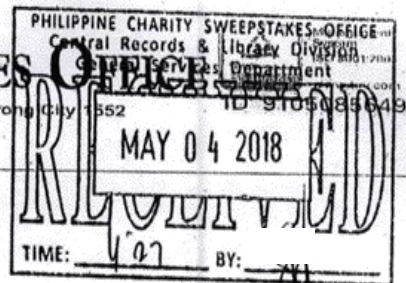

RESOLUTION NO. 0102-B Series 2018

Whereas, Republic Act No. 9710, otherwise known as the Magna Carta of Women, is comprehensive women's human rights law that seeks to eliminate discrimination against women by recognizing, protecting, fulfilling and promoting the rights of Filipino women, especially those in marginalized sector;

Whereas, the Magna Carta for Women mandates all government offices to create and/or strengthen gender and development focal points;

Whereas, the Gender and Development Committee recommended the approval of the 2018-2022 Corporate Theme to align objectives of GAD programs and projects with the agency's mandate under RA 1169, as amended (PCSO Charter), mission, vision and agency targets;

WHEREFORE, the Board **RESOLVED** to approve the 2018-2022 Corporate Theme: "Gender-responsive gaming for empowered and healthy Filipinos", subject to compliance with applicable laws, rules and regulations on the matter.

4. Per the records of the Office of the Board Secretary, the foregoing Board Resolution has not been replaced, amended or repealed.
5. This Secretary's Certificate is issued for whatever legal purpose it may serve.
