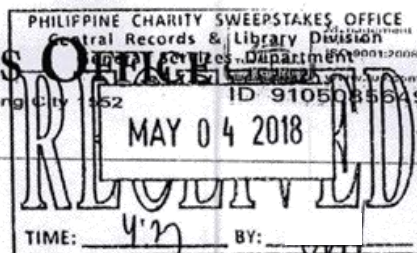

SECRETARY'S CERTIFICATE

1. I am the Board Secretary V of the Philippine Charity Sweepstakes Office (hereinafter referred to as "PCSO"), an agency of the national government engaged in the operation of sweepstakes and lotto;
2. As such, I have custody of all records pertaining to the Board of Directors of the PCSO including all Board Resolutions;
3. Per the records of the Office of the Corporate Secretary of the PCSO, the Board of Directors thereof, during its **2nd Special Board Meeting held on 05 April 2018** at Marco Polo Hotel, Davao City passed the following Resolution:

RESOLUTION NO. 0103-C Series 2018

Whereas, Republic Act No. 9710, otherwise known as the Magna Carta of Women, is comprehensive women's human rights law that seeks to eliminate discrimination against women by recognizing, protecting, fulfilling and promoting the rights of Filipino women, especially those in marginalized sector;

Whereas, Magna Carta for Women mandates the generation and maintenance of gender statistics and sex-disaggregated databases to aid in planning, programming and policy formulation;

Whereas, the Gender and Development Committee recommended the collection of sex desegregated data for all major programs of PCSO;

WHEREFORE, the Board **RESOLVED** to approve the collection of sex desegregated data for all major programs of PCSO, in such manner and frequency as may be recommended by the GAD Focal Point System (GFPS), to aid in policy formulation and program/project development and implementation;

RESOLVED FINALLY that this shall be subject to compliance with applicable laws, rules and regulations on the matter.

4. Per the records of the Office of the Board Secretary, the foregoing Board Resolution has not been replaced, amended or repealed.
5. This Secretary's Certificate is issued for whatever legal purpose it may serve.
