ANNOUNCEMENT

The public is hereby informed on the resumption of the PCSO Medical Access Program through the NCR Online Application System with additional coverage on the assistance effective February 1, 2022.

Please refer to the documentary requirements and procedure on how to avail medical/financial assistance.

1. Prepare the following requirements:

► Confinement

- Original/certified xerox copy of medical abstract with license number and signature of the doctor;
- Official Statement of Accounts with signature of the Billing Officer less Philhealth and other deductions;
- Valid ID of the patient (photocopy).

► Erythropoietin (dialysis injection)

- Original/certified xerox copy of medical abstract with license number and signature of the doctor;
- Original prescription of epo injection with license number and signature of the doctor;
- Original endorsement with official quotation (applicable for Dialysis Center and hospital);
- Valid ID of the patient (photocopy).

► Chemo drugs

- Original/certified xerox copy of medical abstract with license number and signature of the doctor;
- Original prescription with license number and signature of the doctor;
- Original or Certified True Copy of the Treatment Protocol;
- Three (3) official quotation from different suppliers if not available from the hospital/dialysis center;
- Valid ID of the patient (photocopy).

► Specialty medicines (Hemophilia, Post Kidney transplant medicines, Rheumatoid Arthritis, Anti-Lupus, Immunocompromised Disease (IVlg), Psoriasis, Orphan Diseases, Idiopathic Thrombocytopenic Purpura (ITP), Thalassemia and Neuro-psychiatric).

- Original/certified xerox copy of medical abstract with license number and signature of the doctor;
- Original prescription with license number and signature of the doctor;
- Three (3) official quotation from different suppliers if not available from the hospital;
- Valid ID of the patient (photocopy).

ANNOUNCEMENT

▶ Hemodialysis

- Original/certified xerox copy of medical abstract with license number and signature of the doctor;
- Original endorsement with official quotation from the Dialysis Center and hospital;
- Certification of Philhealth benefits availment from the Dialysis Center and hospital or Certification of Philhealth exhaustion;
- Valid ID of the patient (photocopy).

▶ Laboratory (blood chemistry) and Diagnostic and Imaging procedures

- Original copy of medical certificate with license number and signature of the doctor;
- Letter of Acceptance for guarantee letter;
- Official quotation from the hospital/Diagnostic Center;
- Valid ID of the patient (photocopy).

▶ Implant and Medical Devices (pacemaker, septal occluder, valves and PCSI devices such as Stent, Balloon catheter)

- Original copy of medical certificate with license number and signature of the doctor;
- Letter of Acceptance for guarantee letter;
- Three (3) official quotation from different suppliers;
- Valid ID of the patient (photocopy).

2. Scan all the documentary requirements;

3. Go to the official PCSO website at <https://www.pcsso.gov.ph>, click E- Services and click NCR Online Application for Medical Assistance to proceed with the application;

4. Fill-in the required information and details of the patient;

5. Upload the scanned documents to the system;

6. Wait for the notification of the status of the request to your email within the day. If approved, print the *Guarantee Letter (GL)* and the *MAP application form*;

7. Submit the printed *Guarantee Letter* and *MAP application* form including the complete documentary requirements to the Hospital, Dialysis Center, partner health facility (PHF)/medicine retailer and Diagnostic Center;

A notification on the status of the request via email shall be provided within 24 hours from the submission of application and complete documents.

The MAP NCR Online application is open only from Monday to Friday (except legal holidays or special non-working day) from 8:00 am in the morning until we reached the allowable number of cases based on our daily budget. You may apply the next day in case the allowable number of cases based on daily budget been reached.
